This is for the information of all concerned that in case a candidate, who has filled his/her online Admission form in time, paid the requisite fee, has any grievance and feels that the Statutes governing Admission have not been adhered to, he/she may make an appeal on the Form prescribed for the purpose and remit the requisite fee of Rs. 440/- (Rupees Four Hundred Forty only) w.e.f. 20-12-2021 to 23-12-2021.

The decision of the Appellate Committee shall be final and binding.

The applicant can download the Appeal Form from the JUET Website www.juetonline.in All the requisite details are to be filled in by the applicant in his/her own handwriting. The applicant who desires to prefer an appeal will have to submit the Appeal Form(s) to the concerned Head(s) /Director(s) /Nodal Department(s) along with all the requisite documents and requisite fee receipt.

1. Only genuine grievance where Statutes governing admission have not been adhered to will be accepted. Incomplete and spurious appeals will not be considered.
